Revised Schedules

Only a certified steward shall be authorized to sign a change of schedule. The alternate shall sign in the absence of the steward. The President shall sign in accordance with Article 17.2.b of the 2006 - 2010 Collective Bargaining Agreement.

Any work performed outside of bid hours shall be considered out-of-schedule and shall be paid at the out-of-schedule rate.

A signed change of schedule, by an authorized steward or officer shall waive the Postal Service from the out-of-schedule payment in accordance with the Employee and Labor Relations Manual.

All change of schedules must be for personal convenience and the signature of the authorized steward or officer shall so indicate.

Any attempt to change the hours of a bid through the use of change of schedule shall be the standard for triggering the re-bidding procedure.

Change of schedule forms must be completed in full before being signed by the officer or steward.
